BOARD OF FINANCE CANDIDATES

The BOF's primary responsibility is to protect the financial well-being of the Town, and it has done a great deal to improve the town's financial integrity by imposing discipline and transparency in the management of our capital spending and our long-term liabilities. The BOF has not imposed the same discipline on the town's spending and taxes in the understandable belief that the Board of Selectman and the Representative Town Meeting (i.e., the town's Executive and Legislative branches) should decide what services the town should provide. Also, because its authority is limited to changing specific line items in the budget, it has no way of knowing how any changes it makes would be implemented, and what their ultimate effects would be. Thus, on the critical issue of what services the town wants and can afford, the BOF has generally deferred to the BOS and the RTM. The BOF also has no role in the negotiation or approval of any Town or School labor contracts.

The Board of Finance consists of nine members who are elected to six-year terms (three members are elected every two years). Under the Town Charter, no more than six of the nine members can be registered with the same political party. Still serving their unexpired terms are four Republicans and two Democrats. This means that at least one of the two Republican candidates and at least one of the two Democratic candidates will be elected to fill one of the three open seats. Also, John Mitola (D) is running unopposed this year to complete the remaining two years of a term to which he was appointed due to a prior resignation.

You can vote for two candidates...the top three will be elected:

Kevin Hoffkins (D)

Kevin Lennon (D)

James Walsh (R)

(Incumbents are Italicized)
