



## This Week's Focus:

## **TOWN PLAN & ZONING CANDIDATES**

Many do not realize how important this Commission is to the quality of our lives and the value of our homes and businesses. Through its legislative and administrative control of zoning and subdivision regulations, the TPZ has enormous power over what and where people can build (e.g., housing density, "McMansion's"), and thus over the size of our population, school enrollment, how much traffic there is on our streets, the character of our neighborhoods, how well we protect our environment and natural resources, and how much of our tax burden falls respectively on the owners of residential, commercial and industrial property. The TPZ must also respond to applications by developers to build high-density housing anywhere in Town under State law "8-30g," which allows them to ignore all zoning regulations if they set aside at least 30% of their new units as affordable housing.

The TPZ consists of seven voting members and three alternate members. Every two years, three voting members are elected to four-year terms and one voting member is elected to a two-year term. All three alternate members are elected to four-year terms, but this year one alternate member will be elected to fill a two-year vacancy. Under the Town Charter, no more than five of the seven voting members, and no more than two of the three alternate members can be registered with the same political party. There are two Republicans and one Democrat on the Commission whose terms have not expired, so as many as three Republicans or three Democrats can be elected or reelected as voting members this year.

You can vote for two 4-Year Voting Members, three will be elected.

<u>Four-Year Voting Member Candidates</u>: Mark Corcoran (D) - *Currently an Alternate* 

Meg Francis (R) - Currently an Alternate Chris Macalese (D)

Matt Wagner (R) - Incumbent

You can vote for one 2-Year Voting Member, one will be elected.

<u>Two-Year Voting Member Candidates</u>: Jaci Coleman (R) - *Incumbent* 

Walter Dunne (D)

You can vote for one Alternate Member, one will be elected.

<u>Four-Year Alternate Member Candidates</u>: Jeffrey Ng (D)

Thomas Noonan (R) - Incumbent
